### V Reports/Ongoing Business

#### A Report of Chair, Executive Committee

President Sheehan asked Mr. Moore to provide an overview of the NAfME finances. Mr. Moore reviewed the February month to date (MTD) and year to date (YTD) expenses, revenue, and investments. May 2023 continued to follow the usual trend of lower activity compared with the most active months of the fiscal year as the school year comes to a close. We continue to show favorable year to date activity compared with last year, about 8.2% ahead.

President Sheehan asked Western Division Immediate Past President Renee Shane-Boyd to review for the board the candidates for Western Division President-Elect.

President Sheehan reviewed for the board a request from the *Music Education Journal* (MEJ) Editorial Committee to update the current MEJ policy as it relates to the use of more inclusive language, updating the titles of the journals and systems, and the addition of some required language from SAGE about the fact that all articles must be submitted through the <u>ScholarOne</u> system. The board agreed with the recommended updates.

President Sheehan led a discussion with the board about the request from the *Journal for Music Teacher Education* (JMTE) Editorial Committee to update the current JMTE policy as it relates to increasing the size of the Editorial Committee to ensure it can expand its international reach. The board discussed the financial components of increasing the size of the Editorial Committee and came to a consensus to move forward. The board requested data points moving forward to understand the reach of JMTE. The board agreed with the recommended updates.

It was moved by Muller, seconded by Barre, and carried unanimously to approve the updates to NAFME Codified Policy V.E.001 NAFME Juried Journals as presented.

President Sheehan provided the board with an update on the Council of Music Program Leaders (MPL) Forum for 2023-2024. NAfME is in talks with NAMM about the possibility of combining this event with the NAMM Show in January 2024. These talks include the Chair of the Council of MPL, and we will keep the board updated.

President Sheehan requested Southwestern Division President Martha Gabel provide an update on the PLPC. Ms. Gabel informed the board that recorded webinars were being readied now for the NAfME Learning Academy for Fall 2023. A report will also be given to the National Assembly about the ongoing work of the PLPC.

President Sheehan requested Immediate Past President Mackie Spradley update the board on the work of the Equity Committee and the Equity Leadership Institute. The two groups have held joint meetings over the past several months to discuss and plan for the upcoming Equity Resource Center. When the groups meet they are considering questions that will help determine the best resources, how to outline FAQs, and are finalizing working groups to keep the work moving forward. The board will continue to be updated.

President Sheehan requested President-Elect Deb Confredo provide a report of the Music Teacher Profession Initiative (MTPI) task force. President-Elect Confredo informed the board that writing of the report was completed. The report was released on June 20, 2023, in advance of the National Assembly Symposium. Following the National Assembly Symposium, the MTPI Task Force will continue to meet with one another and meet with other internal and external NAfME partners to educate them about the report and hold dialogue about the homework and how each group can contribute to furthering the solutions provided in the report.

President Sheehan reviewed for the board the upcoming trip to the Modern Band Summit. Each Division was sending a representative on the trip, along with President Sheehan, President-Elect Confredo, and a representative from the Council of Music Program Leaders and the Council for Innovations. A planning call was scheduled following National Assembly and the trip will take place in July 2023. The board will be updated following the trip.

President Sheehan provided an update on the conversation between NAfME and the Midwest Clinic leadership about partnering together to create a valuable experience for the Collegiates that attend the Midwest Clinic in December 2023. NAfME is currently discussing a session with President Sheehan, as well as a separate engagement with the Collegiates on site. The board will be updated as plans are finalized.

President Sheehan reminded the board of the relationship with SBO+ Magazine. We contribute a monthly submission to the magazine and President Sheehan is available to talk with anyone on the board about providing a monthly column on a topic of their choice. North Central Immediate Past President Karen Salvador recently submitted a column about divisive concepts laws and the recent report released by NAFME.

#### VI Old Business

President Sheehan discussed with the board planning for the 2023 Fall Division Board Meetings. The NAfME Executive Committee will plan to participate virtually in each Fall Division Board Meeting. President Sheehan reminded the board there was no budgeted financial support for the Fall Division Board Meetings and the State MEAs would be responsible for all financial components if a Division wanted to meet in person. Final dates will be shared with the board and Division Presidents will be sending more information to their Divisions following National Assembly.

President Sheehan and President-Elect Confredo provided a review of the 2023 National Assembly schedule for the board. President Sheehan explained the structure and reporting for the Saturday breakout sessions. President-Elect Confredo explained the padlet links and engaged the board in dialogue about the best way to facilitate the Saturday breakout sessions.

#### VII New Business

President Sheehan reviewed for the board the Diversity Repertoire project and next steps. President Sheehan and staff will work with Immediate Past Chair of the Music Composition Council Rob Deemer on next steps. The board will continue to be updated on this work.
