III Call to Order

President Scott R. Sheehan called the meeting to order at 7:01 p.m. Eastern Time on Monday, November 27, 2023.

V Reports/Ongoing Business

A Report of Chair, Executive Committee

President Sheehan asked Chief Financial and Administrative Officer Chaudlier Moore to provide an overview of the finances. Mr. Moore informed the board that NAfME was at a net loss year to date (YTD), what is not unusual at this time of year. As the current YTD net loss is significant, however, this was flagged by staff and discussed with President Sheehan and President-Elect Confredo in advance of the board meeting. Based on this, Mr. Moore did a deep dive into the numbers and found two areas where revenue projections are not being met:

- membership dues
- grants/contracts

The areas of concern are due to timing and the cycle of membership. We will see if time makes this a bit better and then we can do a recalibration of the budget if that proves necessary. Executive Director Christopher Woodside reminded the board it is extremely important to recall there are two incredible transitions due to the leadership of the board:

- continued growth of membership despite the pandemic and indicators that gave no guarantees for this
- control of expenses is a result of the fiscal controls and blueprint that was put in place under Immediate Past President Mackie V. Spradley

Mr. Moore's staff will continue to review existing contracts and upcoming projects to ensure all expenses are being monitored. Mr. Moore and Mr. Woodside will continue to update President Sheehan and the board as Mr. Moore reviews the financials monthly.

Mr. Moore provided an update to the board about the 2-year budget policy. Staff has provided the final revised policy the board approved at the October 21, 2023 NEB meeting.

President Sheehan asked Mr. Woodside to provide an update to the board on recent advocacy activities. Mr. Woodside informed the board about a possible advocacy collaboration with NAfME's colleague organizations in the arts subject matter discipline areas. Mr. Woodside expressed excitement about the potential for increasing reach and vibrancy in NAfME's advocacy efforts. Mr. Woodside will keep the board informed.

President Sheehan updated the board on recent conversations about Career Technical Education (CTE). This topic has come up in multiple states in regard to Perkins funding that is currently available in this area. States in the Southern and Southwestern Divisions are discussing this topic in great detail. President Sheehan and President-Elect Deb Confredo would like to gather a group of interested members to begin to have this conversation at the national level. President Sheehan is asking the Division Presidents to share information from the state MEAs on this topic. President Sheehan will convene a meeting in the new year to kick off this work.

President Sheehan and President-Elect Confredo led the board in discussion about the 2024 National Assembly planning. President-Elect Confredo is considering a "working meeting" schedule. Staff has provided the Congressional calendar to the Executive Committee which confirms the dates both chambers will be in session for 2024-2025. The board tasked staff to negotiate the best contract for NAfME for the venue and dates. The board will continue to be updated as this work continues.

President Sheehan asked President-Elect Confredo to provide the board with an update on the work of the Music Teacher Profession Initiative and the Music Teacher Profession Advisory Board policy. President-Elect Confredo discussed with the board her recent experience at the National Association of Schools of Music (NASM) annual meeting and the positive conversations she had with the NASM Executive Director. Next steps include a meeting with the NASM Executive Director to continue discussions about the MTPI Blueprint work. President-Elect Confredo is also scheduled to meet again with the NAfME Music Education Policy Roundtable who have requested to form a subcommittee to continue working on the Blueprint and next steps.

President-Elect Confredo reviewed for the board the current draft Music Teacher Profession Advisory Board policy. Feedback from the board has been included in the revised draft policy. Immediate Past President Mackie V. Spradley requested the policy include further defining language for the section, "...with equity as a foundation..." President-Elect Confredo confirmed she would include that further defining language to the final policy language.

IT WAS MOVED BY DAUGHERTY, SECONDED BY GABEL, AND CARRIED UNANIMOUSLY TO APPROVE POLICY I.G.003, MUSIC TEACHER PROFESSION ADVISORY COMMITTEE, WITH THE CAVEAT IT IS TO BE AMENDED WITH FURTHER DEFINING LANGUAGE AS IT RELATES TO EQUITY.

President Sheehan asked North Central Division Immediate Past President Karen Salvador to give the board an update on Divisive Concepts Laws (DCL). North Central Division Immediate Past President Salvador shared the current draft of a second DCL resource she has been working on. This resource contains all the statements NAfME has on this work. It was moved by Brown, seconded by Hammel, and carried, Salvador abstaining, to approve the "division concepts laws: resources for NAFME members" resource as amended to include the NAFME disclaimer.

President Sheehan reviewed the report from the Society for Research in Music Education (SRME) regarding the recommendations for the SRME grant winners.

It was moved by Baumgartner, seconded by Salvador, and carried unanimously to approve funding for the two NAFME/SRME research grants as presented:

- CARLOS ABRIL & GIULIA RIPANI. EXAMINING THE INFLUENCE OF ENVIRONMENTAL FACTORS, EMOTIONS STATES, AND TEACHER STRATEGIES ON PSYCHOLOGICAL AND BEHAVIORAL OUTCOMES AMONG MARGINALIZED AND UNDERREPRESENTED MUSIC EDUCATORS
- JANE M. KUEHNE & MACY L. BELL. LEARNING TO TEACH: A MIXED-METHODS EVALUATION OF AN EARLY-DEGREE MUSIC TEACHING PROGRAM

President Sheehan reviewed the request from SRME regarding the research grant policy. SRME is requesting a change to the due dates in this policy to better align with the current conference timeline.

IT WAS MOVED BY STONE, SECONDED BY GABEL, AND CARRIED UNANIMOUSLY TO APPROVE THE CHANGES TO POLICY I.D.002, NAFME-SRME RESEARCH GRANT, AS PRESENTED.

President Sheehan requested Equity Committee Chair Mackie Spradley provide the board with an update from the Equity Committee. Chair Spradley informed the board the Equity Committee and Equity Leadership Institute members were continuing to work on planning for the Equity Resource Center. Chair Spradley will keep the board informed of their progress.

President Sheehan provided an MIOSM update for the board. NAfME is planning an MIOSM event on Capitol Hill at the end of March 2024. As a reminder, the theme is, "I See ME." The MIOSM logo was released earlier in the fall. Next, staff will promote a video campaign around the theme as part of NAfME's advocacy efforts for MIOSM. The Executive Committee has approved the Choral Council proposal to commission a piece for MIOSM by an under-represented composer. The Societies and Councils continue to support MIOSM through social media campaigns and virtual webinar events.

President Sheehan provided a review of the Artificial Intelligence (AI) Initiative. President Sheehan and staff are coordinating next steps for this project and the Executive Committee will be reviewing the names of active scholars in the music education space. This initiative will consider ways that NAfME will most effectively support music educators.

President Sheehan directed the board to review the NEB Liaison reports in the board book as a recap of the current work of the societies and councils. President Sheehan reminded the Division Presidents of the upcoming joint meeting that will be scheduled with the Chairs of the Societies and Councils to discuss representation on the councils and the upcoming appointment process.

President Sheehan informed the board of his upcoming travel to the Midwest Clinic. There will be a Workforce Coalition breakfast where he plans to discuss further alignments of messaging, and review and feedback on current messaging. President Sheehan will be presenting an advocacy session, and NAfME will have a booth in the exhibit hall that will have new resources about careers in music education that is geared toward students. President Sheehan is planning to gather other NAfME leaders in attendance for dinner one evening during the event.
