V Reports/Ongoing Business

A Report of Chair, Executive Committee

President Deb Confredo asked Chief Financial and Administrative Officer, Chaudlier Moore, to provide an overview of the NAfME finances. Mr. Moore reviewed the April month to date (MTD) and year to date (YTD) expenses, revenue, and investments. April 2024 transactions decreased versus April 2023 transactions. We continue to show favorable year to date activity compared with last year, about .93% ahead. Mr. Moore also discussed business development, grant planning, and membership campaigns with the board.

President Confredo led the board review of the Equity Resource Center (ERC) content, including the "NAfME Prologue" document. President Confredo reminded the board this was the culmination of nearly a year of work by the Equity Committee to provide one of the resources that was requested in the NAfME Strategic Plan. The ERC will contain a NAfME Prologue, FAQs, personal stories, and a Sage DEIA Virtual Collection of articles. These items were all curated by the Equity Committee. The board discussed each item and were very supportive of the project and the content that was collected. The board provided feedback on each component of the ERC. It was requested that Angelica Brooks, Equity Committee Co-Chair, go back to the committee with feedback. The ERC will be previewed by the board again before promotions begin.

The meeting schedule and work will pick up when the committee is back together at the beginning of the school year later this summer.

President Confredo asked Immediate Past President Scott Sheehan to provide an update on the activities of the Career and Technical Education (CTE) work group. Mr. Sheehan noted that staff compiled background information and data to help inform the CTE work group plans. The work group is considering a webinar in the fall and then this work would be handed off to the Council of Music Program Leaders to determine how best to move forward. The board will continue to be updated.

President Confredo led the board in a discussion about the Lowell Mason donation designation. Currently, all NAfME awards are going through a review with the Equity Committee. During the review process for the Lowell Mason donation, former Equity Committee Chair Mackie Spradley asked the board to consider designating the funds for a specific purpose other than the general fund. In the past, donors have inquired about where the funds are allocated. Each year the number of submissions for the Lowell Mason Fellowship varies. President Confredo requested the Awards Committee review the feedback from the board and bring back recommendations to the NEB.
